Tenants and Advisors Early Experiences of the Local Housing Allowance and Money Management

CRSP has been commissioned by the Department for Work and Pensions to explore (qualitatively) tenants' and advisors' early experiences of the LHA national roll out, with a particular focus on issues arising from the direct payment of LHA to tenants and how tenants manage their LHA money. This research forms part of a wider two year review to monitor the impact of LHA at a national level.

Review of the Child Material Deprivation Items in the Family Resources Survey: Qualitative Element (MIS Necessities)

The Department for Work and Pensions commissioned CRSP to investigate what items parents consider are essential necessities for families with children in Britain. Drawing on the methodology used in the MIS study, this qualitative research is designed to help update the government's measure of deprivation in families with children. It has informed the design of a large-scale survey (the ONS Omnibus Survey) asking members of the public which items they think that every family in Britain should be able to afford if they want them, whose results in turn will be applied in future Family Resources Surveys to measure how many families lack a selection of items that the public considers to be necessities.

Minimum Income Standards: Rural costs

In 2008 CRSP launched the findings of a major piece of research aimed at exploring what people thought was needed in order to have a minimum acceptable standard of living. This research was primarily undertaken in towns and cities, but included

limited research in rural areas, which highlighted that there may be additional or different costs for those living in rural or remote locations. As a result of this research, the Commission for Rural Communities has commissioned CRSP to explore these additional costs.

Mobilizing Identities: The Shape and Reality of Middle and Junior Managers' Working Lives

The aim of the research is to chart the work of middle and junior healthcare managers; including identity work and to produce an ethnography of the lived experience of middle and junior management within the distinctive organisational context of the NHS. It will explore the identities (goals, values, motivations, beliefs and interactions styles) of middle and junior healthcare managers to see how these are constructed and how they shape the performance of roles. The project also investigate how such managers leverage their identities to create success, establish trust and broker alliances to exert influence in different and various spheres of their working lives and to see in what ways they use their identities to take forward organisational, group and personal goals. Lastly, it will determine the influence of managerial identities on organisational processes and outcomes; including what constitutes an effective manager.

Evaluation of the Right2BCared4 Pilot

The Right2BCared4 initiative is based on the principle that cared-for young people aged 16-18 should have a greater say in the decision-making process preceding their exit from care and that they should not be expected to leave care until they reach the age of 18. A three year pilot, funded by the Department for Schools, Children and Families, began in October 2007 involving approximately 1,100 young people from 11 local authorities.

An evaluation of the pilot is being undertaken by the Centre for Child and Family Research and the Centre for Research in Social Policy (both at Loughborough University) in conjunction with the National Care Advisory Service, Catch 22. The findings from this evaluative study will provide information on the effectiveness of Right2BCared4 and whether the scheme has helped care leavers achieve better outcomes. CRSP is involved in the quantitative elements of this mixed-method study. This includes the design of a survey of cared-for young people, and the subsequent analysis, as well as the analysis of management information data provided by local authorities.

The original MIS research was designed to produce a minimum income standard for Britain that did not account for possible variations in Northern Ireland. Research in Northern Ireland investigated the extent to which different budget levels are appropriate there.

Process and Impact Evaluation of Accessibility Planning

CRSP, in partnership with Atkins, have been commissioned by the Department for Transport to evaluate the process and impact of Accessibility Planning. This is a process that aims to promote social inclusion by helping people from disadvantaged groups or areas access jobs and essential services. The evaluation will take a holistic view of Accessibility Planning and will involve considering the processes by which Accessibility Planning is implemented but also the impact that Accessibility Planning policy has had on the work of local authorities and wider partners, and on individuals and communities.

The Impact and 'True Value' of Culture and Sport in Crime Reduction

CRSP is working in partnership with ECOTEC Research & Consulting and the University of Huddersfield to conduct a national research project to investigate the impact of cultural and sporting interventions in crime reduction. The objectives of the research are to explore *how* culture and sport contributes to crime reduction, what *impact* this has, and to develop an *evaluation framework* that can be used by projects and services in the future. The research is being conducted in three stages:

- o Stage One - A Rapid Evidence Assessment of the literature around the subject;
- o Stage Two - Case study research; and
- o Stage Three - Development of a cost-benefit model.

The Children's Market: characteristics, trend and strategies

As part of its ongoing commitments under the Children's Plan, the Department for Children, Schools and Families and the Department of Culture, Media and Sport commissioned an independent assessment of evidence relating to the impact of the commercial world on children's wellbeing. The assessment examined children's commercial world in the broadest

sense, and was not limited to a focus on advertising. It took account of the beneficial aspects of children's engagement with commercial activities, as well as potentially problematic outcomes. CRSP and the Department of Social Sciences have been commissioned to undertake a review of the marketing and advertising industries' strategies towards children and young people.

Disadvantage and Road User Safety

It is well established that more people are injured on the road in disadvantaged areas than in other areas. For example, in order to meet its target of halving the number of children killed or injured in road accidents, the Government is prioritising a focus on reducing accidents in disadvantaged areas and among children from different social and ethnic groups. What is less clear is why such risks are more pronounced for disadvantaged groups. The Department for Transport has commissioned CRSP, in partnership with Faber Maunsell, to undertake a major study to investigate accidents in disadvantaged areas and so inform strategies to improve road user safety. The research started in March 2008 and will continue into 2010.

Accessibility Planning Evaluation: scoping work

In a very tangible way, social exclusion is mediated by 'accessibility' – that is, by people's opportunities to access employment, education, healthcare, affordable healthy food, and social and cultural networks. As part of Local Transport Plans, local authorities have planned strategies to improve the opportunities for those most at risk of accessibility-related social exclusion. As this accessibility planning is put into action, the Department for Transport will be evaluating how it is happening (process evaluation) and what difference it is making to people's lives (impact evaluation). To ensure the best design for this evaluation, CRSP and Atkins were commissioned to examine early developments in accessibility planning and existing relevant evidence, and to develop options for the research methodology.

Where Does The Money Go? Credit and debt today

The extent of personal debt in the UK and its impacts are key policy issues. However, there is a lack of in-depth understanding of the interaction between debt and income – and specifically poverty – over time. A dynamic approach is needed to unpack these complex inter-relationships, examining the interplay between debt and poverty over time.

Although policy acknowledges the association between low income and debt, the link between debt and poverty has not been explored in depth or from a dynamic perspective. This project will provide new insights into how debt is defined and experienced over time by households on low incomes, thereby informing policy aimed at reducing the numbers of over-indebted people and supporting those who experience over-indebtedness and financial crisis. The study will also inform financial inclusion policy through contributing to an understanding of the strategies that are adopted by households in financial difficulties.

Evaluation of the Effectiveness of the New Local Safeguarding Children Boards (LSCB)

CRSP, in partnership with the Centre for Children and Family Research (CCFR), are undertaking an evaluation of the effectiveness of Local Safeguarding Children Boards (LSCBs) in England. This will explore the structures and processes adopted by LSCB to fulfil their core functions. It will also examine whether these new structures and processes have overcome identified weaknesses of Area Child Protection Committees and promoted inter-agency co-operation. The research is designed to contribute to the development of LSCBs by ensuring learning is fed back to national, regional and local policy-makers and implementers. It will examine the effectiveness by assessing practice against an evidence base that already exists in the social sciences about strategic partnership working. A mixed method approach will be adopted and will include: national mapping of LSCBs (web based survey to identify models of practice and organisational structure); interviews with LSCB chairs, strategic partners and practitioners in six case study areas; and social network analysis in two areas in order to explore in detail how partnerships operate at strategic and operational levels and how procedures are put into practice.

The issues covered by this study are central to the current government agenda for children's services, underpinned by the Children Act 2004, to ensure an integrated approach to service provision and that children are safeguarded and their welfare promoted.

Evaluation of the Older Workers Face-to-face Guidance Pilot

The Government's Green Paper: A New Deal for Welfare: Empowering people to work, includes a commitment to increasing employment among people aged 50 and above. As part of the process, the DWP is funding a pilot study whereby independent advisors offer guidance to people of older working age about a range of issues related to work and retirement. CRSP has been contracted to evaluate this pilot. The study aims to establish what information older working people need, and how they can access it, in order to make an informed decision about work and retirement in later life.

Understanding the Experience of Ethnic Minorities at Loughborough University

Loughborough University commissioned CRSP to undertake a research project into the performance and experiences of ethnic minority students at Loughborough. The University sought to understand whether existing data demonstrated anything about the experience of its applicants and students, and whether ethnic minority students were having less positive experiences at Loughborough than white students. The research approach was both quantitative and qualitative - it drew on existing data available through the University systems and developed a range of focus groups and one-to-one interviews with a wide-range of participants.

Tackling the Transport Barriers to Social Exclusion: the potential of individual transport budgets

The Department for Transport commissioned CRSP to undertake a 'think piece' about the potential of using individualised budgets to ensure that people at risk of social exclusion have access to key services and employment and education opportunities. The idea of Individual Travel Budgets (ITBs) was to provide financial assistance for transport directly to individuals as an alternative to transport subsidies and concessions. As apparent from the introduction of Direct Payments for disabled people, for example, individualised budgets can offer service-users greater flexibility and control over service provision. The context of the project is the accessibility agenda and the growing recognition of the central role transport has for social inclusion. The project reflected the DfT's efforts to look at the most innovative policy options to ensure accessibility for everyone. The project provided formative thinking about the potential benefits and challenges of providing ITBs, considered the implications of ITBs for other services and provision, and assessed the possible cost-effectiveness of individualised assistance.

Gendered Citizenship in Multicultural Europe: The Impact of Contemporary Women's Movements (FEMCIT)

Work Package 4: Ethnic and religious citizenship. Intersections between feminism, ethnic identity and religion in a multicultural Europe.

This qualitative study aims to:

- o explore and assess understandings of the impact of minority women's organisations on the anti-violence and anti-racist policies of the majority feminist movements, thereby identifying best practices and poorer practices in terms of policy development at both the nation-state and European level.
- o explore how religious European women define, construct and practice citizenship in their everyday life, thereby identifying and assessing how religious identities and practices may

- o provide resources and barriers to citizenship; and
- o understand how different groups of women (minority and majority feminists and women adhering to different religious traditions) understand and practice citizenship as both national and European citizens, and how they perceive the importance of social identities (ethnicity, gender, class, sexuality) for their citizenship practice.

The data for the project will be collected through the use of qualitative research methods, with in-depth interviews of relevant individuals. Fieldwork will take place in Norway, the United Kingdom and Spain.

The study is divided into 3 strands:

1. Cross-national comparisons of feminist organisations working to eliminate racism and violence against women and their impact on policy making.
2. Cross-national comparisons of progressive and traditional women within different religious traditions.
3. A contested notion of citizenship: what does citizenship mean for women in different communities?

National Youth Agency Briefing Papers

The National Youth Agency (NYA) commissioned a series of five briefing papers on the Every Child Matters core outcomes for children and young people - one for each theme. The five outcomes are: to be healthy; to be safe; to enjoy and achieve; to make a positive contribution and; to achieve economic wellbeing.

CRSP, drawing on the expertise of Professor Alan France, was responsible for writing two of the papers. These papers focus on making a positive contribution and staying safe strands of Every Child Matters. The papers provided an overview of relevant government policy, drew on academic research evidence and considered the contribution youth work made to delivering services for young people across the local authority. The papers were also used to raise awareness of youth work.

Labour Market Impact of New Tax Credits

This project examined the impact of Child Tax Credit (CTC) and Working Tax Credit (WTC) on the labour market participation of women with children, and explored the reasons for non-take-up among the eligible population. More specifically, the study examined the effect of CTC on mothers' employment and the effects of WTC and CTC on their weekly working hours, separately for lone mothers and those in couple families. The project analysed the last three waves of the Families and Children Study 2002-2004, which is a longitudinal survey containing a representative sample of all families with dependent children in Britain.

The analysis involved propensity score matching techniques, panel regression, event history modelling, and simple descriptive methods.

The project was directed by Sue Middleton and supported by Yekaterina Chzhen, Professor Phil Robins and Dr Monica Magadi.

A Minimum Income Standard for Britain

This project brought together the expertise of CRSP and the Family Budget Unit (FBU) in order to develop a minimum income standard that would allow an acceptable standard of living in Britain for different family types. The research blended the consensual budget standards method pioneered at CRSP, with the FBU expert or 'normative' approach, thus ensuring that the minimum income standards was rooted in social consensus about the goods and services that everyone in modern Britain needed, while at the same time drawing on expert knowledge about basic living requirements and actual expenditure patterns.

The project included an extensive analysis of behavioural data using the Expenditure and Food Survey which helped to set the budgets in the context of how families prioritise resources in real life. It also drew on previous work to derive a model to establish what income would be required to meet the minimum income standard. It also produced a basis for uprating and rebasing the budgets over time.

Sue Middleton and Karen Kellard (now at BMG Research Ltd) developed and refined the Consensual Budget Standards methodology in CRSP during the last ten years. Jonathan Bradshaw re-pioneered the use of budget standards in the UK and is the Director of the Family Budget Unit at the University of York.

Link between HIV/AIDS and recent fertility patterns in Kenya

This project examined the possible link between the HIV/AIDS epidemic and recent fertility patterns in Kenya, based on the 2003 Kenya Demographic and Health Survey (KDHS) data. The 2003 KDHS provided a unique opportunity to study the impact of the HIV/AIDS epidemic on affected populations, being the first of the international DHS programme to anonymously link the HIV/AIDS results with key behavioural and demographic factors. Kenya had experienced one of the most dramatic fertility declines in world history, but the decline had surprising, stagnated, and even reversed in some regions of the country. Earlier evidence from the 2003 KDHS showed interesting regional patterns with respect to fertility trends and the HIV/AIDS epidemic, but the relationship between these two remained unclear. The specific objectives of this study were to:

- o examine regional variations in the link between HIV/AIDS and fertility;

- o explore possible mechanisms through which HIV/AIDS influences fertility; and
- o examine the effect of contextual community HIV/AIDS factors on fertility.

The analysis was carried out at the aggregate (regional) level and at individual level and features multilevel analysis, particularly in the investigation of community/district level contextual factors.

The Definition of Disability in the Workplace

The research provided a comprehensive, systematic and robust assessment of the debates on the monetary and non-monetary costs and benefits to employers of employing disabled people. DWP commissioned Mathematica to produce a review of the literature, and UK experts were asked to produce chapters for a report and a conference, which was held in Autumn 2005. CRSP were asked to explore the definitions of disability and of incapacity as they apply to the workplace. The definition of disability in particular was contested and different definitions would lead to varying estimates of the numbers of people affected. The chapter by CRSP examined definitions of disability and incapacity that impact upon employers, and their awareness of these definitions especially of disability as outlined in the Disability Discrimination Act 1995. Brief discussions of relevant Jobcentre Plus employment programmes, such as New Deal for Disabled People and Access to Work, and of the disability element of Working Tax Credit were held.

Examining the Role and Operation of New NDDP Job Brokers

As part of the ongoing evaluation of the New Deal for Disabled People programme, CRSP was commissioned to undertake further research examining Job Broker effectiveness. The research focused on ten Job Brokers in five different geographical areas to attempt to understand why some Job Brokers appeared to be more effective than others, and to identify areas of good practice. This case study approach included qualitative interviews with Jobcentre Plus staff and Job Broker staff in each of the five areas. The research report was published in September 2006.

Evidence Based Review on Mobility – Choices and Barriers for Different Social Groups

CRSP was commissioned by the Department for Transport to conduct an evidence based review of the empirical social research available on mobility choices and barriers for different social groups. The Department for Transport's overarching aim is to

provide transport that works for everyone. Transport is a key gateway to helping people access jobs, education, health services, leisure activities and other provision such as food shopping. Factors such as the availability, physical access, affordability, personal safety concerns, poor travel information and variation in travel aspirations can deter people from using transport to access these facilities and services and can thus reinforce social exclusion.

This review provided important policy information about the mobility of different social groups (such as families, older people, disabled people, different minority ethnic and faith groups) and how transport provision and policy impacted upon their choices. The report was published in 2006.

Children's Perspectives of Social Difference

This research funded by the Joseph Rowntree Foundation with support from Save the Children, explored different children's perspectives of their own lives. It compared and contrasted different children's views and experiences of social difference, inequality, social exclusion and inclusion. Forty two children, aged between eight and thirteen, consisting of separate groups of girls and boys, participated in eight small groups. The children were from contrasting backgrounds: 19 lived in a disadvantaged estate and participated in services provided by Save the Children; twenty three children were from an independent, fee-paying, school. There were some key similarities between the children. These included an emphasis on relationships and activities as most important in their lives, and the importance of education, free time, favourite things, and friends and family. None of the children identified themselves as poor or rich. Both groups of children stressed the importance of not being seen as different from their own peer group. 'Poverty' and 'wealth' were considered alien concepts by both groups of children, relating only to 'other' people in extreme circumstances. However, the children perceived social difference in terms of 'chavs' and 'posh' people. Their perceptions of these groups were predominantly antagonistic in tone. Despite these similarities in views and values, the research found some striking differences in the children's educational experiences and free-time. The research has implications for citizenship education and extended schools, and highlights how important open public space is to less affluent children.

Ex-Prisoners Study: An Exploratory Investigation into Links Between the Criminal Justice System, Jobcentre Services and the Labour Market

Ex-prisoners are a particularly disadvantaged group in the labour market, experiencing high levels of unemployment, low grade or no qualifications, poor health, especially in relation to substance misuse and personal barriers such as low self-esteem and confidence. This research was an exploratory study that aimed to gain an in-depth understanding of:

- o the attitudes and expectations of prisoners immediately prior to and following their release from prison; and

- o their views on the impact of support services on the decisions they made and experiences following release.

Planning and Deploying Resources in Later Life: aspirations, attitudes and behaviour – a qualitative study

This project funded by the Joseph Rowntree Foundation explored how older people used and valued the resources available to them, as well as how they had planned for retirement and were planning for future later life. A central aim of the project was to examine how resources changed over time and how changes in people's later lives impacted on their plans as they moved through retirement. This led to a better understanding of the relative importance of financial wealth and other resources at different points in people's post-retirement lives, and according to changing circumstances. A qualitative longitudinal approach was adopted using a panel of respondents aged 65 to 84. The first wave of in-depth interviews took place during Summer/Autumn 2005. Respondents were re-contacted during 2006 to gather a brief update on any changes in circumstances, with follow-up interviews in 2007.

Training and Reporting on European Social Security (trESS)

The trESS network organises training and networks on the European co-ordination of social security schemes in the 25 member Countries. It was funded by the European Commission and implemented by Ghent University in collaboration with independent high profile experts on European Social Security in all the member countries. The aim was to increase the knowledge base on the co-ordination regulation and to build strong networks rooted at national level encompassing public administrations, employers' organisations and trade unions, NGO's, judges, lawyers, and independent experts dealing with implementation in all the 25 member countries. trESS, also identifies and informs the European Commission of problems and challenges at operational level in the member states.

The Public Sector Response to the Provisions of the Disability Discrimination Act

The Disability Discrimination Act 2005 makes substantial amendments to the 1995 Act, building on amendments already made by other legislation since 1999. This study examines public bodies' performance in relation to new provisions introduced on 1 October 2004; and provided a baseline against which to assess the extent to which the duties in the 2005 Act

make a positive impact on disability equality. The study was led by CRSP and was carried out in collaboration with British Market Research Bureau.

The Social Fund: Current Role and Future Direction

With the support of Sir Richard Tilt, Social Fund Commissioner, CRSP completed a Joseph Rowntree Foundation funded project exploring the current role and future direction of the Social Fund.

The discretionary Social Fund was established in 1988 to provide financial support for people on low incomes experiencing exceptional needs. It has always been a controversial part of the welfare system and the Select Committee on Social Security (2001) questioned whether it was succeeding in helping the poorest and most vulnerable in society, concluding that without reform 'there is a strong possibility that the wider social policy objectives of the Government will be endangered'.

This research project explored what contribution the Social Fund makes to the Government objectives of reducing poverty and social exclusion; assessed whether proposals for changes are likely to further these objectives; and produced policy recommendations for reform of the Social Fund based on the experiences, reflections and deliberations of both eligible and non-eligible groups. The research methods used included a literature review, secondary data analysis and focus groups.

Needs and Resources in Later Life (Quantitative)

This project aimed to inform future social policy by investigating needs and resources in later life. Whilst extensive research has been undertaken on income poverty among older people, less is known about the interplay between needs, resources, aspirations and perceptions of adequacy. The research investigated the interplay between these factors at a point in time and considered how this varies by characteristics such as gender, health status, household composition and age. It questioned whether the association between these factors changes across the later life course and the extent to which variations can be attributed to changes in health status, household composition and income. The project entailed a secondary analysis of a number of large-scale datasets, including the British Household Panel Study, the Expenditure and Food Survey and the Poverty and Social Exclusion Survey of Britain.

A Systematic Review of Poverty Dynamics Research

In recent years, there has been an expansion in the availability of longitudinal data, leading to a wide range of studies exploring poverty dynamics, both in Britain and internationally. However, despite the increased attention to poverty reduction in Britain, and at the international level, it appears that the influence of poverty dynamics research on policy has been relatively weak.

The research applied appropriate systematic review methods to synthesise the best available evidence on the dynamics of poverty and disadvantage, with the aim of helping to move concerns with poverty persistence up the policy agenda, suggest possible policy solutions, and highlight gaps in research.

Risk Perceptions and Responses, and Transitions in the Life Course

This project is part of the ESRC-funded research network, Social Contexts and Responses to Risk. The project's aims were to explore:

- o individuals' and families' responses to, and perceptions and experiences of risk events, and the consequences of risk events;
- o how responses to risk might change at different points in people's lives and in different generations; and
- o the extent to which responses to risk draw on, and are shaped by, personal networks and public institutions.

The project comprised a survey of 1400 respondents, and a qualitative study of 30 families, involving an interview with a parent and adult son/daughter in each family.

Evaluation of the School Sports Co-ordinator Programme

The School Sports Co-ordinator Programme (SSCoP) is a joint initiative of the Department for Education and Skills and the Department for Culture, Media and Sport. Launched in September 2000, it is aimed at increasing the participation among school age children in sports, improving the standards of performance, and increasing the number of qualified and active coaches. The programme is implemented by Sport England and currently involves approximately 809 schools in England. School Sports co-ordinators are tasked with improving sports provision and sport teaching by creating, at the local level, a network of schools linked, if possible, to specialist sports colleges. The effectiveness of the programme in delivering its policy objectives was evaluated by CRSP jointly with the Institute of Youth Sport, Loughborough University (who led the consortium), and the Centre for Developing and

Evaluating Lifelong Learning (CDELL) at the University of Nottingham. The evaluation commenced in 2003 and completed in 2009. The evaluation is funded by Sport England.

Evaluation of the Adult Learning Grant (ALG)

The ALG is a means-tested learning grant designed to support adults studying full-time for their first full level 2 qualification or young adults studying full-time for their first full level 3 qualification. The ALG was introduced in September 2003 and was piloted in ten areas across England. The ALG forms part of the government's Skills Strategy and aims to encourage more adults to gain basic and intermediate level qualifications. The consortium consisted of the Centre for Research in Social Policy, the National Centre for Social Research (NatCen), the Institute for Fiscal Studies (IFS) and the National Institute for Careers Education and Counselling (NICEC). Evaluation of the Local Housing Allowance Pathfinder
